Notice of KCHA Board of Commissioners' Special Meeting

A special meeting of the Board Commissioners will be held from Monday, March 24, 2014 commencing at 7:00 a.m. to Wednesday, March 26, 2014 at 5 p.m. in Washington DC. The meeting includes sessions held at times and locations listed below. All times except for the departure from SeaTac are EDT.

Agenda for the meeting includes discussions of administration, personnel, policy, fiscal and regulatory issues relating to KCHA and the affordable housing industry. Meetings with elected officials will be used to brief them on these issues and encourage support from legislators for KCHA initiatives. No final action will be taken during the meeting.

There will be an executive session on March 25 at dinner. The purpose of the executive session will be to discuss the performance of a public employee (RCW 42.30.110(g)) and to consider the selection of a site or the acquisition of real estate by lease or purchase when public knowledge regarding such consideration would cause a likelihood of increased price. (RCW 42.30.110(b)). The executive session is estimated to last 2 hours.
