Affirmative Action

Sarah Crane, Senior Recruiter explained in detail what the Affirmative Action Plan is and placement goals for KCHA.

AAP – Affirmative Action Plan (AAP) is a plan or program that outlines a federal contractor or subcontractor's efforts to provide equal employment opportunities and generally support the advancement of employees regardless of gender, race, disability or veteran status.

What is a Placement Goal?

- Placement Goals are set only for minorities and females when incumbency is less than reasonably expected when compared to availability.
- Placement Goals equal the Total Availability for the affected class per job group.

What a Placement Goal is NOT!

- Unlawful preferential treatment and quota.
- Set-asides or a device to achieve proportional representation of equal results.
- Requirement that any jobs be filled by a person of a particular gender, race or ethnicity.

D. KCHA Physical Infrastructure Improvements

Nikki Parrott, Director of Capital Construction and Weatherization

There are necessary improvements for the 600 building. These are preliminary plans and budgets for these plans. We are in an exploratory phase and will come back to the board once we have more details and costs.

VIII. EXECUTIVE DIRECTOR REPORT

Robin Walls, Executive Director/CEO gave news updates.

- We have received an award for the digital equity grant from the FCC in the amount
 of \$171,263. Expanding working with households that do not have access to
 broadband/internet access. We are looking forward to implementation of this.
- Director of Safety and Security started today Ponha Lim. We look forward to introducing him at a future board meeting.
- We still have ongoing challenges. There has been another incident in Kent at Mardi Gras last week. We are still staying tuned with respect to that issue.
- Good news on Federal front, we received word last week that HUD has abandoned their plans to change their plans to convert housing authorities from a Grant funded contract, and instead, is allowing housing authorities to continue to have annual contribution contracts. That would have changed our relationship with HUD as far as how we receive our funding.

- Richard Jackson who will be our next Board member will be meeting with the local services and land use sub-committee and then will be meeting with the full King County Council. We are anticipating him to become official in April or May.
- Dan Watson will be retiring on May 12, 2023. He started at KCHA in December of 1976 at 22 years old, just out of graduate school after working as a summer intern with HUD for three years. He's worked in housing for over 48 years. The work here has always been challenging and interesting, but has had the opportunity to work within a great organization that has always been progressive, innovative, creative and ethical. For all of the progress that we have made, all the work that we have done, all the units of housing created, the challenges that low income families and individuals finding housing today is unfortunately far greater than it was when he first started.

Dan thanked the Board and all of his colleagues for their support and help that he has received throughout these years.
