**RESOLUTION NO. 5380**

**AUTHORIZING THE EXECUTIVE DIRECTOR TO ENTER INTO AN  
INTERLOCAL AGREEMENT WITH VANCOUVER SCHOOL DISTRICT  
NO. 37 FOR THE PURPOSE OF PURCHASING WORKSTATIONS  
FOR THE 700 ANDOVER BUILDING**

**WHEREAS**, the King County Housing Authority needs to purchase 80 workstations in connection with the office remodeling work at the 700 Andover Building; and,

**WHEREAS**, KCHA has previously purchased workstations manufactured by HON which were of good quality at a reasonable cost and would like to purchase additional HON workstations for the 700 Andover Building; and

**WHEREAS**, KCHA often uses cooperative purchasing arrangements such as The Cooperative Purchasing Network (TCPN) that use open and competitive procedures that are substantially the same as KCHA's to obtain volume discounts on manufactured items such employee workstations; and

**WHEREAS**, the HON workstation needed by KCHA is not available in Washington State through TCPN but is available through a competitively bid purchasing agreement with Vancouver School District No. 37; and

**WHEREAS**, Chapter 39.34 RCW The Interlocal Cooperation Act, permits public agencies to cooperate and exercise joint powers in carrying out their public purposes, including the purchase of goods and services; and

**WHEREAS**, Vancouver School District No. 37 routinely enters into Intergovernmental Cooperative Purchasing Agreements with other school districts and public agencies in order to reduce the cost of goods and supplies; and

**WHEREAS**, the Vancouver School District No. 37 has used competitive bidding procedures which are substantially the same as KCHA's to obtain a reasonable and fair per workstation price for the HON workstations needed by KCHA and is willing to enter into an Intergovernmental Cooperative Purchasing Agreement allowing KCHA to purchase the workstations at that price.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE HOUSING AUTHORITY OF THE COUNTY OF KING:**

The Executive Director is hereby authorized to enter into an Intergovernmental Cooperative Purchasing Agreement with Vancouver School District No. 37 substantially in the form attached hereto for the purpose of purchasing up to 80 HON workstations at a cost not to exceed \$140,000.
