RESOLUTION NO. 5663

**AUTHORIZING THE EXECUTIVE DIRECTOR TO ENTER INTO AN
INTERLOCAL AGREEMENT WITH OAKLAND HOUSING AUTHORITY IN
ORDER TO ACQUIRE CONSULTING SERVICES**

WHEREAS, the Oakland Housing Authority seeks to secure a consultant to advise the Executive Director in HUD programmatic and regulatory guidance as well as administration, operating and management assistance; and

WHEREAS, the King County Housing Authority (KCHA) has previously utilized interlocal, cooperative purchasing agreements with in- and out-of-state public agencies; and

WHEREAS, KCHA has followed the HUD procurement process 2 CFR 200 and KCHA's Procurement Policy in procuring consulting services with CVR Associates, Incorporated; and

WHEREAS, the service needed by the Oakland Housing Authority is available through the King County Housing Authority through a competitively bid contract with CVR Associates, Incorporated; and

WHEREAS, Chapter 39.34 RCW The Interlocal Cooperation Act permits public agencies to cooperate and exercise joint powers in carrying out their public purposes, including the purchase of goods and services; and

WHEREAS, KCHA routinely enters into Intergovernmental Cooperative Purchasing Agreements with other public agencies in order to reduce the cost of contracts and supplies; and


WHEREAS, KCHA has used competitive bidding procedures which are substantially the same as Oakland Housing Authority to obtain a reasonable and fair price for the service needed by Oakland Housing Authority and is willing to enter into an Intergovernmental Cooperative Purchasing Agreement allowing the Oakland Housing Authority to piggyback on their existing contract at a comparable price.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF THE HOUSING AUTHORITY OF THE COUNTY OF KING; as follows:

The Executive Director is hereby authorized to enter into an Intergovernmental Cooperative Purchasing Agreement with the Oakland Housing Authority substantially in the form attached hereto for the purpose of allowing the Oakland Housing Authority to piggyback on the KCHA contract with CVR Associates, Incorporated.
