**WHEREAS**, Nancy Holland-Young was appointed to the King County Housing Authority's Board of Commissioners effective March 2004 and brought to the Board an unwavering commitment to the provision of affordable housing for low income households as well as broad knowledge and experience in organized labor and advocacy for working people; and

**WHEREAS**, Commissioner Holland-Young provided invaluable counsel to the Board and staff of the King County Housing Authority in fulfilling its mission for over eight years; and

**WHEREAS**, Commissioner Holland-Young ably served as Chairperson of the Board of Commissioners from May 2007 to May 2012 during which time the King County Housing Authority significantly expanded housing opportunities for low income families, the disabled, and homeless individuals, and developed the Greenbridge and Seola Gardens communities, which are the largest development projects ever undertaken by the Housing Authority; and

**WHEREAS**, Commissioner Holland-Young's term of office expired in May 2012, but she continued her service to the King County Housing Authority while awaiting the appointment of her replacement with the same dedication and commitment that she displayed throughout her tenure; and

**WHEREAS**, Commissioner Holland-Young enjoys the everlasting respect and friendship of her fellow Commissioners and the staff of the Housing Authority.
