Federal Tax Deadline

File by **Tuesday, April 15, 2025** to avoid penalties.

Essential Tax Credits

- Federal Earned Income Tax Credit (**EITC**)
- Washington State Working Families Tax Credit (**WFTC**)
- Child Tax Credit (**CTC**)
- Additional Child Tax Credit (**ACTC**)

Tax Extension

Request extension by **April 15, 2025**. This gives you

until **October 15, 2025**, to file your return.


